Attendance roll call was taken.

Treasurer Malek moved to approve the regular session minutes from the June 21, 2023 Board Education Conference. Mr. Metzger seconded. Motion carried.

Rep. Mayhew moved to approve the regular session minutes from the June 22, 2023 Board Meeting. Treasurer Malek seconded. Motion carried.

Ms. Jacobs moved to approve the regular session minutes from the September 7, 2023 Special Board Special Meeting. Mr. Metzger seconded. Motion carried.

Ms. Spieler discussed the proposed 2024 Board meeting schedule. Mr. Metzger moved to approve the proposed Board meeting schedule, as presented. Ms. Jacobs seconded.

Ms. Beckham and Mr. Hoge presented the MSEP and Judicial Plan annual actuarial valuation reports for the period ending June 30, 2023. After Board discussion, Ms. Jacobs moved to adopt the employer contribution rate as follows: 28.75% for FY25, 30.25% for FY26, and 32% in FY27. Sen. Black seconded. Motion carried.

Mr. Metzger moved to adopt 61.34% as the FY25 employer contribution rate for the Judicial Plan. Mr. Findlay seconded. Motion carried.

Mr. Keifer provided the Investment Committee report.

Mr. McEnery presented the MOSERS 2<sup>nd</sup> Quarter summary performance report.

Mr. Carlson presented the MOSERS 2<sup>nd</sup> Quarter investment performance report.

Mr. Hankins provided the quarterly risk report.

Mr. Carlson, Mr. Rehfeld, and Mr. Hankins provided information on MOSERS' historical performance reporting and portfolio composition.

Mr. McEnery provided information on asset allocation practices of public fund peers.

Ms. Jacobs provided the Audit Committee report.

Mr. Metzger provided the Strategic Planning and Governance Committee report. Mr. Findlay moved to approve the proposed revisions to the MOSERS Governance Manual, including non-substantive changes. Sen. Rizzo seconded. Rep. Mayhew voted in opposition. Motion carried.

In accordance with Section 610.021 (1), (3), (11), (13), (14), & (17), RSMo, Ms. Jacobs moved to go into executive session for the purpose of approving the minutes, hearing the litigation/legal report, discussing the External Auditor contract extension, and personnel matters. Mr. Metzger seconded. A roll call vote was taken. Mr. Findlay, Mr. Campbell, Ms. Jacobs, Mr. Keifer, Rep. Mayhew, Sen. Rizzo, Ms. Wessing, and Commissioner Zellers voted in favor of the motion. Motion carried. Sen. Black was not present for the vote.

Upon return to open session, Mr. Campbell moved to adjourn the meeting. Mr. Metzger seconded. Motion carried.
