Attendance roll call was taken.

Ms. Wessing moved to approve the regular session report from the January 18, 2023 Strategic Planning and Governance Committee meeting. Mr. Findlay seconded. Motion carried.

Ms. Spieler updated the committee on the progress of the strategic plan and discussed a proposed revised date for the asset liability study. After committee discussion, Mr. Findlay moved to recommend that the proposed revised date for the asset liability study on the Strategic Plan be presented to the full Board for consideration at the June meeting.
